General Requirements

- Minimum 21 Years of Age
- Legal U.S. Work Authorization
- Valid U.S. or Foreign Passport with Applicable Visas.
- Able to Travel without Restriction (U.S. and Canada)
- Fluent in English, Written and Spoken
- High School Diploma or General Education Degree (GED)
- Minimum 2 Years Customer Service Experience
- Able to Work from Denver, Houston, and Washington Dulles Bases
- Satisfactory 10-year Background History, Including Criminal Background.

If you have been convicted of a criminal misdemeanor or felony within the last five years, you are not eligible for a crewmember position due to Canadian Immigration Regulations. Canada also has a strict inadmissible class or status that includes no conviction of DWI/DUI. If you have been on probation or convicted of a DWI/DUI or misdemeanor within the last 10 years, you are not eligible for a crewmember position unless you show proof that you have received a letter of approval from Canada.

Physical Requirements

- Ability to Push/Pull/Lift Objects Weighing up to 70 lbs. and Move a Beverage Cart
- Minimum Height of 4'11" and Maximum Height of 5'11"
- Standing or Walking for Extended Periods
- Physical Strength to Reach and Operate All Emergency Equipment And Exits
- Demonstrated Ability to Work in Aircraft Aisles and Galleys—Standing, Reaching, Walking, Kneeling, Bending, Twisting, Working in Cramped or Awkward Positions, and Squatting
- Fit into the Jump Seat and Harness without Any Modifications
- Comply with Company Uniform and Grooming Standards at all Times while on Duty
- No Visible Tattoos
- Ability to Walk and Fit Comfortably Down the Aircraft Aisle while Facing Forward
- Ability to Fit Quickly through the Over Wing Exit
- Ability to Hear and Respond to Customer and Crew Communications in Situations with High Background Noise
- Outdoor Exposure to Weather

Schedule

CommuteAir operates flights every day of the year, requiring flight attendants to work a variable schedule including nights, weekends, and holidays. Flight attendants bid on schedules, which are awarded based on seniority.
